Goolawah Greenthumbs Patch

How to Keep your Citrus Happy and Healthy, Advice from Citrus Grower *Contribution from Mairead*

We were at Bellingen Spring Plant fair and there was a very interesting talk by a Commercial Citrus Grower. He worked in commercial citrus orchards for many years, and saw the poisonous sprays they used every week, including a final waxy spray that is left on the fruit prior to sale. He considers such fruit to be toxic and hence set up his own orchard, and has dedicated himself to producing organic citrus fruit on a commercial basis by keeping trees healthy and encouraging an environment where beneficial insects can flourish. He has done many experiments to find the best methods, including use of laboratory tests. He shared his knowledge with us and answered our many questions. Below are his top recommendations to have healthy citrus:

- Keep grass away from underneath citrus trees. In tests he did, trees kept clear had
 twice the growth of trees with grass growing around the trunk. As trees get larger,
 their shade will inhibit vegetation anyway. If you do mulch around trees to keep
 vegetation down, no not use bark or fresh grass cuttings as this will create nitrogen
 deficiencies. Hay is best, Lucerne being his favourite.
- 2. Forget commercial fertilizers, **well rotted manure** gives trees everything they need, including trace elements. Chicken poo is the best of the manures. Top dress with a generous amount 3 times a year. Chicken manure is all he uses, and finds lots of good manure is the single most thing that helps keep trees healthy and allows them to cope with any stresses such as dry seasons or diseases.
- 3. To fight baddies and disease, the only spray he recommends is **Eco Oil**, which is a vegetable oil product. Do not use White oil as this is a petroleum product and impacts beneficials. You can make your own eco oil by mixing water and vegetable oil, recipes on the net. He uses Eco oil for aphids and scale. With scale you must spray on the affected bark to smother the scale. If the scale is very bad, you can get a brush and soapy water and brush it off. He said not to worry about leaf miner or sooty mould as they do not harm the tree sufficiently to merit spraying. The best defence against fruit fly is good orchard hygiene. You need to break the fruit fly cycle by picking up rotting or split fruit and burning them or taking them off-site. Do not compost as the fruit fly larvae will hatch and multiply and the problem will only get worse over time.
- 4. **No need to prune** citrus, unless they are getting too big/tall for your liking or if there are dead branches. Some citrus trees grow really tall and need to be cut down in height. If you do prune, make sure it is during a dry weather period, to avoid fungal diseases.
- 5. **Don't over water citrus**, they don't like wet feet. He only waters trees when he first plants them. Watering too frequently means the tree may not develop deep roots and the tree becomes very dependent on artificial irrigation.
- 6. **PH of 6 6.5** is ideal. If your soil is very acid put a little bit of dolomite but do not go mad. In clay soil areas a bit of gypsum is good to help break it up.
- 7. Plant trees in **full sun** and mound the soil. Use good compost in the hole, do not put manure in the hole. The addition of top dressings of manure over time mean you gradually raise the level of the tree, improving drainage and encouraging new surface roots to grow to feed from the manure.

Varieties he recommended were:

Oranges – Choose a selection of varieties that will give you fruit throughout the year. Washington Navel; Lanes Late Navel comes on four weeks after the Washington; and Valencias which come on after the navels.

Lemons: Lisbon – lovely taste;. Eureka fruits the most often during the year but has big spikes; Myer is very sweet but too sweet for those looking for a sour lemon flavour, makes a great dwarf tree.





Ordinary Resolutions for the Meeting

Ordinary Resolution 1: That all members who build dams must consult with neighbours prior to construction.

Proposed by: September Community/directors meeting.

Rationale: A dam can have impacts on neighbours' sites in a number of ways, such as altered run-off, and may restrict the location of grey water systems.

Ordinary Resolution 2: That all members who build a structure or plant a tree that will create a shading issue on their neighbours' blocks consult with neighbours prior to doing so.

Proposed by: September Community/directors meeting.

Ordinary Resolution 3: That a road levy of \$800 be charged to each site, due at the end of the 2013-14 financial year.

Proposed by: September Community/directors meeting.

Rationale: Our DA conditions require that Illa Langhi Rd and Nevertire Rd be upgraded. Whilst we are in negotiations with council over the degree to which they are upgraded, it is unavoidable that road works will need to be done. An \$800 levy will raise \$62,400 towards these works.

Ordinary Resolution 4: That Nevertire Road is nominated to council as our primary entrance.

Rationale:

To take Illa Langi to council standard it needs to be 6m wide which means a massive cost in widening and moving power poles let alone raising it if required, otherwise Illa Langi road is currently maintained by us and is in general kept in good condition. Nevertire road is in need of maintenance, is 6M + wide does not flood to the same extent and making it our primary access on paper will help with cattle issues.

Proposed by Paul & Seconded by Anne

Ordinary Resolution 5: To work with Connection Creek Pastoral to erect a 2 strand electric fence from North Gate along the Western side of North Gate Road to the area known as the sand quarry. From there it is to go due west through the scrub (a track will need to be slashed) and connect with our western border fence that has been recently upgraded by our neighbour Jason (west of Cockatoo Ridge). This would avoid the wetland area (currently dry) that is north of Goldmine Hill that swings around west to the bottom of Cockatoo Ridge.

Connection Creek Pastoral will then agist their cattle in this area. Stocking rates will vary depending on weather condition and availability of fodder with the emphasis on starting small and constant monitoring in order to avoid any negative impacts. This project will be exempt of our by-law of no cloven hoofed animals. Map/arial photographs and on the ground photos will be available at the meeting and anytime prior to the meeting. Contact Craig.

Proposed by Craig Seconded by Ralph

Rationale: The two main aims of this proposal is to 1. STOP THE COWS! (thanks Mr PM) and 2. To begin clearing this area of Goolawah to reduce the potentional fire hazard, gain more access to the area in order to reduce noxious weeds and feral

animals. With the aid of future planning this area can be aligned with our original vision of using parts of this land for permaculture projects including regeneration, reafforestation and agriculture.

First stop the cows! On the 21st September, Isaac (my son) joined me on a walk from North Gate along our northern boundary and then southwest to the junction of our western boundary with our neighbours Jason and Don. The fences here have been down in many areas for a long time and it is very obvious that cattle belonging to our neighbour (J. Langford) have been roaming in this area for some time. Some sections of the fence are OK and other areas wouldn't take too much work to fix. (See photos) Other areas however go through wetland that is still very wet and possibly always will be.

I have walked through this area many times over the last 12 years. It use to be quite clear with some camphor laurels spreading from the North Gate area and only small amounts of lantana. Over the last 4-5 wet years there has been a lot of regrowth – some of it good and some of it weeds. I am always excited and disappointed when I hike through this area as it represents an incredible opportunity to demonstrate how permaculture can turn degraded cattle/agricultural land into land that benefits both humans and wildlife. It is disappointing that we are currently doing a poor job at managing this land. When we first came to Goolawah the thought was "we are not running cattle so why fix fences" – in fact we started taking them down. When most of our neighbouring properties are running cattle, however, you quickly see how ignorant this thought process was.

This is where Connection Creek Pastoral comes in as they are currently managing and agisting cattle on neighbouring properties. To fence our northern boundary completely will cost a large amount of money. CCP has estimated that to fence off an area for agistment will cost them about \$5000. They don't want their cattle coming up into our residential areas and are keen to help keep out Langford's cattle. Community doesn't stop at our gate and at least CCP are making an effort to be part of the solution.

As for part 2 of the rationale it speaks for itself. We have had a lot of new members over the past 5 years who probably have not been in this area or are familiar with the original vision for this land. This proposal is not watertight and will no doubt generate more questions than answers. Ralph and I have put up this proposal to generate debate in a constructive forum and determine by vote where the community currently stands on this issue.
