#### **Business Arising**

## **Treasury**

- Discussion on inactive members with aged debts:
  - o Ben Adams, not picked up correspondence at either address, Treasurer to exhaust remaining contact options with him (text, email) and come back to next meeting with update.
  - o Grant Woolcock, picked up first letter, Treasurer to follow usual procedures
  - Justin and Leah Letter to be sent from Secretary requesting they meet with directors to discuss their financial affairs and agree a way forward (Craig and Anne will abstain from meeting). Treasurer to follow usual procedures.

## Roads

George McKweon came out to assess roads and quoted \$23,000 for works on Frog Hollow, Illa langi to
past camp kitchen, Nevertire, North Gate, Red Hill Road. Total tonnage of roadbase is 330. Works to
commence next week or after Easter. All in Favour to go ahead. Thanks to Ralph.

# DA

- Peter been following up with Councillors to arrange meetings with them and encourage a site visit. Secured a speaking slot at March 15th March Council meeting to address Councillors.
- Still getting the run around from Council staff regarding a meeting with them. Peter and Ralph repeatedly followed up on our January letter where we requested a meeting with Director of Environment Robert Pitt. Pitt or senior staff are not making themselves available or responding. Got verbal commitment for a meeting with Shane Rheinhold (Planner) and Les Palwak (Compliance Officer), but still no date/time.
- Peter met Local Member Melinda Pavey. She took a copy of S.96, was sympathetic and gave a commitment to the speak to Mayor. Not her direct responsibility, but may have some influence.
- Advice from lawyer is that we have been denied procedural fairness

- Options open to us: (1) request councillors rescind the decision on procedural grounds (this is at their discretion), thus setting the decision aside; (2) we request a S.96AB review of the decision which means the decision will be reviewed and voted on again by Councillors; (3) bring Class 4 Proceeding in the Land Environment Court to get decision set aside; (4) make a complaint to ICAC or Ombudsman. Note winning on procedural issues is not enough, we still need to get the road access condition changed from Type 3. Advice from lawyer is that unless the decision is changed or set aside, the date for lodging appeal in Land Environment Court still stands as June.
- More road engineering input may be required, e.g. detailed costings, up-dated traffic counts.. If funds for this are required before next meeting, DA committee will seek approval through a majority board decision
- Intend to engage with neighbours on Nevertire regarding road issue. Michael Clancy and Ishbel offered to help. Ishbel offered to be the Goolawah's Community Liaison Contact. Introductory letter from Ishbel to neighbours read to the meeting. Supported with some edits required. DA Committee to follow up with Ishbel.

- Andy, Membership Application, Cindy 2nd share (Paul processing) still promising action but not delivering
- Deb, Joint Membership with Dave Van Meg Deb advised she now has police record available and ready to progress application, Mairead will hand over historical paperwork to Lexie to process.

#### **General Business**

- Red Hill Fire Shelter pegged out, next step pouring footings. Need to demonstrate reasonable progress on construction as it is a DA Consent Condition.
- Camp Kitchen Roof Extension Council Building Inspector Lyn Kingma back, inspected holes all OK.
   Commented on how big the temporary Building Inspector had insisted the holes be made.
- Old Tyres from Machinery Shed clean out anyone welcome to take, otherwise bring to tip by end of April
- Gas Hot Water Service question about who owns it, answer is the Co-op
- Hot Water Tank no use for it at present, put on Goolawah Facebook buy/swap/sell
- Lantana in wildlife corridor between Chris and Walter put on next working bee list
- Work Claims for setting up new Fire Striker ok to submit claims, refer to job list for approved category
- Debt Collection Agency. Discussion of information from local Debt Collect Agency. Resolution to go forward from this meeting to April GM that Goolawah use debt collection services as a tool to recover debts from members who have not been paid up members for 2 years. Decision to be made a case-by-case basis by a meeting. Proposed and seconded by meeting. 9 in favour, 2 Abstain, 0 Against. Rationale: its another tool besides share forfeiture and eviction when members do not make reasonable plans/arrangements with the Co-operative to repay aged debts and regain active financial membership; members don't want to be debt collectors nor should we ask them to be; people take debt collection agencies seriously; such agencies are effective in the collection of debts; it has worked well for other communities; any costs incurred by Goolawah from use of a debt collection agency would be passed on as a charge to the debtors.
