## **Voting Rights**

Peter explained the rules as they stand.

Rule 28 clearly explains that one membership has one vote including joint members. Discussion followed. Rebekah raised the question that if a joint member was the owner of a separate share,+ paid another joining fee, then would that entitle the member to another vote? Ralph + James to do research with Fair Trading re this matter.

Inactive Members - If you are in arrears with your levy payments, you are ineligible to vote at meetings. Treasurer sends an up-to-date list of inactive members, to the Secretary + Chairperson prior to each meeting. We will be enacting this policy from now, so please be aware of your financial position when it comes to voting.

## Complaints Resolution Team.

- Rob makes the point that when this policy is approved the community will elect a team to manage the process.

# Proposal to go to January GM:

# Rule change for Work Levy. Special Resolution for January GM.

A Work levy is imposed on all membership of the co-op, at the amount of \$180 per annum, to be reviewed periodically at a GM. The levy is dischargeable by work hours contributed to the Co-op, in accordance with the Approved Job List, at a rate of \$10 per hour. A completed "Work Claims" form is to accompany claims, presented at a monthly community meeting for approval.

## DA Report

A meeting was held on 13 November with Robert Scott and Shane Reinhold at KSC. Roger, Peter, + Ralph attended, along with our road engineer Mike Dutton.

Robert Scott agreed that Nevertire Road upgrade can be a "staged development" with "Type 3 elements", rather than the original requirement of a full 6m sealed solution. He requested that Mike Dutton prepare a road design with gravel on low section, passing places (every 250m) and 4m wide tar in front of neighbour residences. Robert Scott said unequivocally that council would never approve a road that did not have the possibility of total seal in the future.

It appears that Robert Scott wants to ignore our outstanding S96 + proceed within the framework of our existing DA consent conditions. The discussion with him about reaching an appropriate threshold of vehicle movements (vehicles per day- VPDs) to trigger further sealing developments into the future seemed to be agreed also, with a bi-annual review. Those thresholds have not been set at present, but Council has since set up vehicle movement counting devices on both Nevertire + Illa Langi.

We also reminded Council of Mark Dunn's infringement on the Crown Road Reserve of Illa Langi, and Reinhold promised to inform the Dept of Industry/Lands.

Following review by the DA Committee, Mike Dutton's response to Robert Scott was

adjusted and sent to Council along with the appropriate road design. We now await Robert Scott's response.

### Road Report:

- Recent pot-holing carried out by working bee,+ much appreciated
- It was suggested that next time we plan to do maintenance on Illa Langi Road, that we make a proper application to the Dept + do it 'legally'.

### Fire Report:

- November 15<sup>th</sup> was the deadline to have your block slashed before the summer gets into full swing. Any empty blocks that need slashing?
- Ralph vH used his gurney,+ cleaned up the fire striker- (Thanks Ralph)

### **Machinery Report:**

- Mechanic found that oil filter was very dirty on our tractor. Now working,+ new filter ordered
- Universal joint on old slasher needs replacing. Waiting for part. The meeting expressed thanks to Roger for his dedication.

### Membership Report:

An overview of membership enquiries during the last 12 months:

- -Approximately 24 enquiries, mostly coming through our wonderful website. A few come from friends of existing members, or other personal connections, + a few come on to us from Cyndis ads.
- resulting in 2 new memberships
- 18 were casual enquiries ( 3 visited + 1 was a media enquiry.)
- 4 pending/in process.
- On average then 2 enquiries per month need responding to.

Cindee + Jim have almost completed their membership application process.

Clint + Noemi also going thru membership application.

Aaron going through his membership application too.

Wendy is here making her first visit.

Peter reminded the meeting of the primary importance in the membership process of the essential "legal" requirement of members to have Goolawah Co-Op as their 'principal place of residence'. They sign a declaration to that effect during the process, + it should be considered an important approval criterion.
