## Goolawah Co-operative Rules - 2018 Revision

## **Background**

In NSW co-operatives are primarily governed by the Co-operatives National Law (CNL), the Co-operatives National Regulations (CNR), and the Co-operatives (NSW) Regulation 2014.

A co-operative is required to have a set of rules which address each of the topics set out in Schedule 1 to the Co-operatives National Law (CNL). Other provisions of the Law or the Co-operatives National Regulations may also specify that particular matters may or must be set out in the rules.

The Co-operatives National Regulations contain a set of rules that may be used by a general co-operative. These rules are called "model rules" because they are drafted to ensure that they include all matters that are required to be included in a co-operative's rules. A co-operative is not required to use the model rules, but instead it may prepare its own rules or it may use some of the model rules and draft others to complete its rules so that they comply with the Co-operatives National Law.

It is important to note that a co-operative's rules must be approved by the Registrar. If a co-operative chooses to prepare its own rules and the rules do not make provision for a matter set out in Schedule 1 to the Co-operatives National Law, then the Registrar may insert the relevant model rule to complete the co-operative's rules.

The Policy and Guidelines Committee have revised and prepared a draft set of rules by cross-referencing Goolawah's current rules with Bundagen's Rules (updated 2014/15), the Model Rules for a non-distributing co-operative with share capital, and the CNL. Many of Bundagen's rules are the same or similar to Goolawah's rules. All references to the old 'Act' have been replaced with the relevant new 'CNL'.
