Discussion

Artist Stage Progress

Progress and options for the mobile stage proposed by Larry were discussed, with an approved budget of \$3000.

Trailer has been purchased, dismantled ready for rust proofing and design is being prepared by Kevin. Goal is to complete in time for New Year's celebrations. The plan is to build in stages - floor, sides and then roof. As the

stage is mobile, the design is determined by usage and mobility requirements. For example, drop sides may make it easier to locate on individual lots.

It was agreed that updates will be included in upcoming General meetings.

DA Roads Progress

Peter provided a history of the Co-op's DA access roads. Dan has arranged for a meeting with Kevin Hall, date and time to be confirmed. The plan is to continue with design and road build quotes and evaluate our position once quotes are received. Wayne has questions to ask Kevin, including what is the council requirements beyond what is specified in the DA consent. Also, what is the progress of the Section 138?

Last Resort

Last resort is progressing. There was discussion on usage, progress and the DA Fire Safety Schedule.

Fire Striker Shelter at Red Hill

We agreed that Survey results tabled at the last community meeting were of low confidence due to the number of returns received. Wayne will continue to work with Dave Launt and those who have strong views on use of the Last Resort and location of the Fire striker shelter.
