1.1 Administrative Matters

- Proposal for Denise to join as Policy Coordinator; the role would involve coordinating policy updates as needed
- **Five directors approved** the creation of the Policy Coordinator role and for Denise to take it on
- Action Item: Need to investigate low participation in Policy Committee

- Policy to be updated to reflect community responsibility for respecting the privacy of all members

3. Resident Matters

3.1 NYE incident - Isaac Ryan

- Police called on New Year's Eve due to health episode
- Current status: Isaac Ryan in care, estimated 6-month recuperation
- Following the incident, there was minor property damage reported to Jelly's and Marty's properties

• Isaac R has clearly expressed his desire to sell and leave Goolawah

Actions:

- Wayne/Secretary to follow up on the Police report
- Liaison with the mental health team ongoing (Marty)
- Consideration of protection order for future incidents

3.2 Mohini Membership

- Request to waive joining fee to be taken to the community for discussion. Any
 discussion will require a community member (not Mohini who is not a member) to
 raise a proposal
- Clarification of new membership requirements:
 - Rules on New Members and Infrastructure Shares read by the Board.
 - Clarified requirements for new members, i.e., all new members must pay the joining fee, share capital, and IS upfront and in full.
 - Payment plans not available for new members (Rule 11)

Actions:

- Mohini's membership guide (Lexie)/or MC representative (Anna) to raise this with Mohini.
- Ask the Treasurer to issue an invoice for the total outstanding amount owing on IS share

Definition of New Member used:

new member means a member who joined the cooperative after the commencement of the Terms of Issue under Rules 11 and 14.

Rules mentioned:

- o 11. Qualifications for Membership
 - c. Every new member (definition Rule 1), including new joint members, shall hold a minimum of one fully paid Site Share and one fully paid Infrastructure Share.
- o 14. Capital and Shares:
 - i. Used for infrastructure and road improvements.
 - iii. Compulsory for new members (definition Rule 1) and is allotted when 100% of the nominal value has been paid.
