### **Meeting Notes**

- The Membership Policy was not discussed, as inducting the new MC members was seen as being of more immediate need. The proposed updates to the Membership Policy will be discussed at the next MC meeting.
- The role, expectations and responsibilities of guides, as well as prospective members, were discussed. This included the review of all the membership processes and related documents.
- Guides were encouraged to familiarise themselves with all membership documents.

#### The discussion focused on:

- **EOI** trial has been positive. Along with the EOI, the MC think interested members of the public should be called to speak with them over the phone.
- **Questionnaire** is a stand alone document. Upon completion it is shared with the Membership Guide, who gets it uploaded to the website. Once on the website, the period of the application process starts.
- National Crime Check (police check) and Court Record Search. Guide discusses any issues with PM first, if 'red flags', then concerns are raised with other guides, and maybe then with the Board
- **Time frame** for PMs 2 years to become eligible, EMs 5 years (proposed)
- In-person MC meetings to be held at least before each GM
